Property Description

Set consisting of two autonomous villas located on a single plot of 1,000 m² included in the sale of undivided inheritance, in a consolidated residential area of Alto do Lagoa.

The first villa with 265 m² is divided into two floors: on floor 0 there are two living rooms, an office, kitchen, guest bathroom and garage; On the 1st floor we have 4 bedrooms and 2 bathrooms.

The house needs modernisation works.

The second villa with 127 m² on the ground floor, has a living room with fireplace, kitchen and 2 suites and a bedroom with bathroom.

The two villas are separated on the grounds with the gardens and the swimming pool. Both with privacy between them, they allow multiple uses, ideal for families looking for autonomous spaces for work, guests or family independence, as well as for investors who want to value and market the units separately.

Both villas offer immediate use and high flexibility of use - main residence with support/guest house, multigenerational residence or investment with autonomous profitability of each fraction.
